# Policy for handling personal data – Audio Pro

All personal data are treated responsibly for integrity and in a way that allows the individual to know what information we collect, how we use it and how we do it. This document describes this process.

## What information do we collect and when?

Audio Pro collects personal information when ordering and actively participating in our marketing activities (newsletters, competitions, fairs, o d).

When ordering, we save the following:

#### Order information

- Product information
  - o Purchased product
  - Visited products (pages) and products placed in the shopping cart
- Payment information
  - o Method of payment
  - Credit card (type and country of origin)
  - Country of payment (country through ip-address)

#### Marketing activities

For other marketing activities, we save the following:

- Phone number
- E-mail address
- Type of marketing activity

## How do we use the information

When ordering or participating in other marketing activities, we will save information that may then be used for the following:

- Deliver product to customer
- Provide support and warranties
  - Case management (support, complaints, returns, repairs)
  - Product Warranty
- Offer technical information (eg software updates)
- Market complementary products and services
  - $\circ$  Newsletter
  - o Text messages
  - o Direct marketing
  - o Personalized e-commerce (cookie-based marketing)
- Invite you to participate in customer surveys
  - Product Reviews
  - o Polls

Audio Pro also collects and uses personal data to comply with applicable legislation such as accounting law, tax legislation and the like.

## How long do we save information

We save information that is required to comply with laws, in accordance with the storage requirements of the respective teams.

Information collected and stored on ordering is stored for at least 2, maximum 5 years to enable Audio Pro to meet return / cancellation and warranty terms.

## Unsubscribe from subscription

#### Who can we share your information with

In order to provide our services and deliver your goods to you, we may transfer to, or share your information with, selected third parties.

Suppliers, partners and companies within the Group: In order to fulfill our commitments to you and for other purposes described in this policy, Audio Pro may share your personal data with suppliers or subcontractors as well as companies within the Audio Pro Group.

#### Storage Security

Audio Pro strives to protect your personal information and uses measures to prevent inappropriate or involuntary disclosure, use, access, loss, alteration or damage to your personal information.

Only Audio Pro or our suppliers' employees who need access to your personal information for a specific task will have access to your personal information

As our business is international both inside and outside the EU, your information can be stored both inside and outside the EU.

#### Storage time

Your information will be stored in accordance with applicable law or until you choose to cancel the subscription.

#### Your rights

Right to access your data. You can request a copy of the information we have about you and verify the information we have about you. We strive to give you answers within 30 days.

You are entitled to receive incorrect or incomplete information about yourself changed/corrected.

## Right to be deleted ("the right to be forgotten")

If you do not want to save us your data, you are entitled to have your information deleted, provided that they are no longer necessary for the purpose they were collected for. However, there may be legal obligations such as accounting laws that prevent us from deleting parts of your data immediately. If you have chosen to subscribe to Audio Pro information and this will be revoked, your data will be deleted.
